Geriatric care managers assist families and older adults in coordinating and managing long-term care plans and arrangements. They can help with long-distance caregiving, crisis intervention, counseling and support and other tasks. Many are trained in therapy or daily money management. There is a searchable database of care managers available by state.

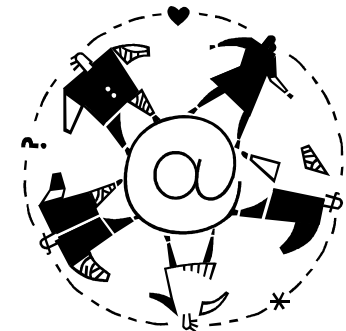

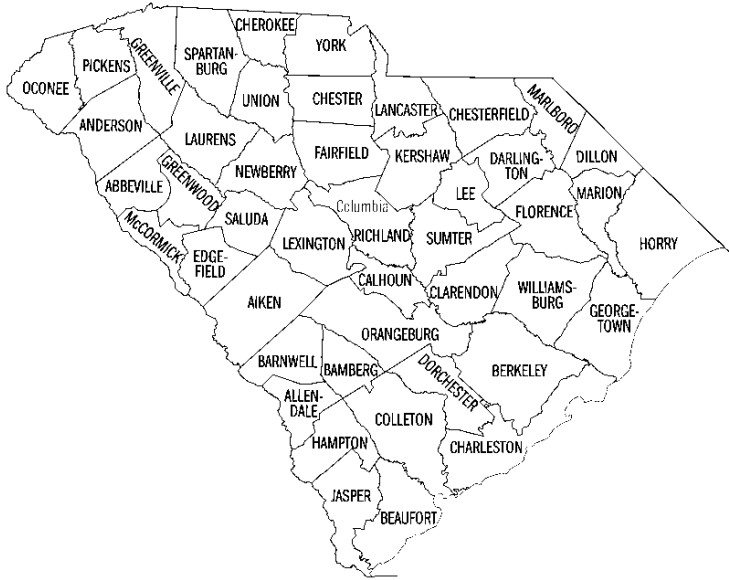

The Family Caregiver Support Program calls for all states, working in partnership with area agencies on aging and local community-service providers to have five basic services for family caregivers, including:

1. Information about available services;
2. Assistant to caregivers in gaining access to supportive services;
3. Individual counseling, organization of support groups, and training to assist caregivers responsibilities; and
4. Respite care to enable caregivers to be temporarily relieved from their caregiving responsibilities; and
5. Supplemental services, on a limited basis, to complement the care provided by caregivers.

Eligible Populations:

- + Family caregivers of older adults; and
- + Grandparents or older relatives over 60 raising a child under 19 years of age (including grandparent who are sole caregivers of a child with development disabilities).
